

## DECLARATION OF CONSENT

# to publish data of project partners of the Felicitas and Werner Egerland Foundation in the Internet on the website of [www.felicitas-werner-egerland-stiftung.de](http://www.felicitas-werner-egerland-stiftung.de)

### Information

The website of the Felicitas and Werner Egerland Foundation, [www.felicitas-werner-egerland-stiftung.de](http://www.felicitas-werner-egerland-stiftung.de), features a “News” section with reports on projects funded by the Foundation.

This includes publication of photos made available by project partners. If project partners provide the Felicitas and Werner Egerland Foundation with photographs for publication, they are responsible for ensuring that the persons featured in such photographs have given their consent for the photos to be published on the website of the Felicitas and Werner Egerland Foundation.

Furthermore, in some cases data of the project partners is also published.

The Board of Trustees hereby points out that sufficient technical measures have been taken to safeguard data protection. Nevertheless comprehensive data protection cannot be guaranteed when personal data of the project partners is published online. It is expressly pointed out that unauthorised manipulation of the data by third parties cannot be completely excluded. The project partner must therefore recognise the risks of potential violation of personal rights and be aware that:

- + the personal data can also be accessed in countries that do not have data protection regulations comparable to those of the Federal Republic of Germany or the EU and
- + the confidentiality, integrity (inviolability), authenticity (genuineness) and availability of personal data are neither ensured nor can they be guaranteed.
